## TJ PTSA Members,

The Bylaws/Governance Committee was formed to consider and propose potential changes to the TJPTSA Organizational Structure Form (LUOS Form), including topics such as membership dues for the next school year, continuation of the President-Elect role, and officer titles.

In order to gather inputs from the membership, the committee sent a survey on March 1. After the survey closed on March 9, the committee discussed the results and used them to deliberate and to make recommendations of changes to the LUOS Form. Per the current Bylaws (July 2021), Section 8. Each member of a local PTA/PTSA shall pay annual dues to the association as approved by two-thirds (2/3) vote of members present and voting after having been given at least thirty (30) days' notice.

The following recommendations will be voted on at the **April 21, 2022**, TJPTSA General Membership Meeting.

- We do not recommend a change to the membership dues of \$40.00. However, this
  committee recommends that the board will provide a free printed directory, rather
  than charging an additional \$10.00 for the directory, to all adult members (one per
  household) while supplies last.
- We do not recommend any changes to the PE position.
- We recommend changing the titles of the First VP of Training to First VP of Programming and Events and the Second VP of Fundraising to Second VP of Membership and Fundraising.
- We recommend changing the Corresponding Secretary position to the Third VP of Communication position.
- We also recommend the following changes:
  - Executive Committee Days Notice Special Meeting (2 days)
  - o Executive Committee Minimum number of meetings per year (6)
  - Executive Board Days Notice Regular Meeting (5 days)
  - Executive Board Days Notice Special Meeting (3 days)
