### **Call Meeting to Order**

• A quorum was determined to be present and the president called the meeting to order (@7:01).

### **Approval of 12/14 EB Meeting Minutes**

- Since the minutes had all been distributed electronically in advance and there was no objection, the minutes were not read aloud during the meeting.
- The minutes were approved as amended.

#### **National Merit Concerns**

- Meeting by Dr. Reid with parents on 1/3/23, Tuesday
  - An independent firm is hired to investigate
  - o Dr. Reid promises to meet with parents after investigation results are obtained
- Dr. Bonitatibus will attend the upcoming GMM but she won't be able to talk about this matter due to the ongoing investigation

- What should be the PTSA's role in this?
  - Yvette: PTSA needs to provide a neutral platform for sharing concerns and for educating parents
  - Par: facilitate discussion of different opinions; while investigation is ongoing, we can educate parents on PSAT, commended award, etc.; A concern is that we won't be able to work on other important things with the administration since they will be busy with this issue.
  - Renee: Counselor has contacted colleges her son applied to let them know his commended status
  - Pratyush: Received calls from parents expressing their anger on this issue; Parents feel like PTSA is not responding to parents' concerns; PTSA is seen as a tool of the administration; Parents' outrage was a result of cumulative concerns related to the TJ administration
  - Nell: PTSA should be cautious about making a statement; better to wait until investigation results comes out; Focus on leveraging committees to educate and alleviate parents' anxiety
  - Colleen: PTSA's role should be listening; we don't have all the data; we have a huge opportunity to educate people; shouldn't make a statement since it can be taken out of context
  - Michele: Her son is affected. It's not just about this commended award. It's really about trust. If PTSA is going to make a statement, we should address the bigger issue. Suggest taking a poll to obtain parents' opinions/concerns.
  - o Ally: Educate parents on the role of the PTSA neutral platform
  - Yehong: Likes the Poll idea. Some parents see PTSA as a tool for the administration
  - Mary Alice: Educate parents on the role of the PTSA and PSAT and other related information; The timing of the poll was important. Sending the poll in the field during a time when emotions were high could result in people focusing on the immediate issue instead of answering the questions with a more long term vision in mind. Thanks to Yvette for waiting to respond until receiving board input.
  - Haiyan: Need to be cautious about the timing of the survey since parents might not have all the correct information
  - Laura: statement takes time to make; good survey is hard to design
  - Yvette: TJPTSA needs to do an annual membership survey; we can expand to allow parents to provide feedback on school overall; Does anyone have any objection to conducting this survey?
    Board will have the opportunity to provide feedback.
  - Mary Alice: what would be the corrective actions after the survey? Need to consider
  - o Pratyush: it's valuable to collect information.
  - o Par: Support survey idea. It's a function expected of PTSA.
  - Yvette will draft the annual survey and will send to the board for feedback.

- Michele: how to differentiate which event people are donating to (for Diversity Committee events)? Nell will respond offline.

### **General Membership Meeting**

  - Think about the option of making general membership meetings members only for future meetings

- Yvette: suggest to only allow members and current TJ students, parents, and staff to attend for the upcoming meeting

  - Ally: Newsletter and website wouldn't be good options. How about Facebook?
  - Nell: Need to consider potential liability in processes
  - Renee: Will post the question to students in the mental health coalition
  - Yvette: parents can address preferences in survey
